
Dear Chair Asing and Councilmembers:

RESOLUTION AMENDING RESOLUTION NO. 2009-02, RELATING TO ADOPTING RULES OF THE COUNCIL OF THE COUNTY OF KAUA'I FOR THE ORGANIZATION OF COMMITTEES AND THE TRANSACTION OF BUSINESS

BE IT RESOLVED BY THE COUNCIL OF THE COUNTY OF KAUA'I, STATE OF HAWAII:

SECTION 1. Council Rule No. 10(c) is hereby amended to read as follows:

“(c) Placement on Agenda. [All] In order to appropriately coordinate the agenda, all bills and resolutions must be initialed by the Council Chair or, in the Chair’s absence, the Vice Chair (or other designated chair as stated in Rule 3) in order to be placed on the agenda. The chair or his designee shall not use this rule to restrict introduction of any bill or resolution introduced by any member indefinitely.”

SECTION 2. Material to be deleted is bracketed. New material to be added is underscored.

SECTION 3. This Resolution shall take effect upon its approval.
