

There are two (2) more weeks left. On March 24, this Saturday from 9:00 a.m. to 1:00 p.m. at the Līhu'e Convention Hall. On March 31, same time, 9:00 a.m. to 1:00 p.m. at Waimea Theater. We do provide child care, so we ask everyone to come out and the responses from the community has been that these homebuyer fairs have been excellent, so we encourage everyone to attend. It has also been well received. We've had over 300 participants that have come through the fairs and being that Saturdays are very busy with soccer and baseball and all kinds of other activities, we are very satisfied with the amount of people that have come out. Also, I would like to also announce that we are having our affordable housing policy workshop that is scheduled on March 27 on Tuesday at 9:00 a.m. here at Council Chambers. The public is encouraged to attend and participate. We are currently in the process of reviewing amendments to Article 2 and 3 of the affordable housing policy. We will be addressing those items first and then we will be addressing the rest of the policy on that day. Again, we encourage the public and also the participants that will be affected which are those companies

that are involved in industrial, commercial, resort developments. So if you are ones that are targeted especially the public which will be affected by this policy, we, again, encourage the community input. Thank you.

Mr. Kouchi: Thank you. Anyone else? If not, there being no further business, we are adjourned.


There being no further business, the meeting was adjourned at 6:47 p.m.
