

MINUTES

**COMMUNITY ASSISTANCE/
INTERGOVERNMENTAL RELATIONS COMMITTEE
August 6, 2008**

A meeting of the Community Assistance/Intergovernmental Relations Committee of the Council of the County of Kaua'i, State of Hawai'i, was called to order by Councilmember Shaylene Iseri-Carvalho, Chair, at the Historic County Building, Room 201, Lihu'e, Kaua'i, on Wednesday, August 6, 2008, at 9:19 a.m., after which the following members answered the call of the roll:

The Committed proceeded on its agenda item as follows:

C 2008-203 Communication (7/18/2008) from Councilmember Shaylene Iseri-Carvalho, requesting agenda time to provide a report on the recent National Association of Counties (NACo) 2008 Annual Conference. **[This item was deferred.]**
